2/25/2013: Election ballot goes out to current members. (Felix gets list of current members from treasurer. What to do if there is just one nomination? Andrew -- need to give people opportunity to opt out of voting for candidate. Felix would not make it obligatory that everything is clicked. Andrew -- make clear in instructions; Ryan would prefer abstention button – abstention button agreed on.} 3/5/2013: Second reminder to cast ballot. (People who join there at conference will be able to vote.) (Felix can download everything and delete it online. Felix will give Andrew access codes and Andrew will double check and verify. Felix won't be able to come to conference but might be able to join by Skype.) 3/8/2013 at 9pm (pacific): Election ballot site closes. Immediate Past-President contacts candidates to

let them know about results and then announces them to the membership.

Ryan sees the position as a good way to bring people into organization.
